## Registration

Registration has to be made in writing by mail or by fax including the signature of the applicant. Inquiries or reservations by phone do not count as an obligatory registration. A written registration is legally binding.

## Confirmation of Registration

The registrations will be accepted in the order of incoming mail. You will always receive a written confirmation (by mail or e-mail).

## Preconditions for participation

Medical/therapeutic education and sufficient knowledge of the human musco-skeletal system.

## Costs and Terms of Payment

You will receive an invoice approx. 6 week prior to the start of the course. Please transfer the invoice amount to the account stated in the invoice within 10 days. Please have in mind that money transfers can take several days until they are credited to our account.

## Cancellation of participation

The course can only be booked as a whole. If participation in one of the sections is not possible, it is to be settled with the organizer how this sequence can be repeated. Cancellations up to 8 weeks ahead of the course will not result in any costs. Cancellations after that date until 21 days ahead of the course will result in cancellation fees amounting to 50 % of the course price. Cancellations at later dates, even in case of illness, will result in fees amounting to 75 % of the course price. If the course instructor can provide an adequate substitute, there will only be a charge of € 40 for administrative costs. **In case of hardship** the decision of Vesalius GmbH and its management is binding. The course instructors have the right to exclude participants from the course within the first two blocks, in case personal or substantial reasons disturb the course. If the course must be cancelled due to reasons for which the organizer cannot be held responsible, including too few participants signing up, the organizer is not liable for the resulting costs (e.g. costs for travel, accommodation and board). The course fee will be refunded in total in this case.

## Preconditions for examination

Graduation in a government-approved medical-therapeutic education/training. Participants may only take the examination after all blocks have been attended and 2 patient protocols have been presented.

## Myoreflex Therapy Certificate

The Myoreflex Therapy certificate will be awarded after the examination has been successfully passed and will be valid for a period of three years. Our quality management requires the participation in a further education course in order to prolong the Myoreflex Therapy certificate every three years. The Myoreflex Therapy certificate or the final examination of the Myoreflex Therapy Basic Course do not qualify the participant to use the professional title "therapist". The qualification to use the professional title "therapist" must be acquired at a government-approved training school.

## Liability

The liability for personal damage and material damage that occurs during Vesalius GmbH courses is excluded according to legal regulations. Participation in the course is at the participant's own risk.

## Changes and Cancellations

Vesalius GmbH reserves the right to make changes of the published courses. This also applies for a short-notice replacement of a course instructor or speaker.
